

## Entity - Self Certification Form (CRS) 實體 – 自我證明表格 (共同匯報標準)

**Please read these instructions before completing the form.**

Regulations based on Organization for Economic Co-operation and Development (“OECD”) Common Reporting Standard (“CRS”) require EBSI<sup>1</sup> to collect and report certain required information based on an account holder’s tax residency status.

根據經濟合作與發展組織 (簡稱「經合組織」) 的共同匯報標準 (簡稱「CRS」) 的規定，光大證券國際<sup>1</sup> 必須根據帳戶持有人的稅務居住身份蒐集及匯報所需相關資料。

Each jurisdiction has its own rules for defining tax residence. In general for entities, tax residence is defined as the jurisdiction where the entity has its place of management. Special circumstances may cause the entity to be resident elsewhere or resident in more than one jurisdiction at the same time (multiple tax residency).
